1. Syd Farrar – He spoke regarding wanting a plan – short term or long term plan to improve the schools. Other discussion was on teacher's pay and benefits; test results and grad results; morale among teachers; and poor leadership. He cannot understand it. When he looks at the economy and those doing with less and soldiers leaving home. Morale is the duty of the leadership. Morale is the result of poor leadership. If you are not pumping up

- the teachers... everything in your power... it's the leadership. Compare teachers to the rest of Nottoway County. He agrees with raising the contribution to \$5,004 for employees. Teachers need to be judged on merit pay. Do not agree with steps. Teachers will always have their job.
- 2. Mrs. Simmons ended Mr. Farrar due to his time allotment. She commented that we have strong leadership and that without a budget, teachers would not have jobs.

This means a school division has been closed an average of eight days per year during any five of the last 10 years because of severe weather conditions, energy shortages, power failures, or other emergency situations.
